The cost given from HCC for the verge protection was based on their contractor doing the work whereas it is envisaged that the FC would carry out the verge protection work. JT asked to ensure that all the appropriate species checks are done prior to the works starting. DS requested TW to ask HCC and to clarify what consultations with businesses and residents are planned and report back to the board. OV asked the FC to supply an estimate of cost for removal of the tarmac/concrete from the mitigation/compensation laybys.
